It is the policy of Code Serve Ltd to:

- Control of noise, dust, odour, vibration, traffic movement or other nuisance or environmental effects which may cause offence to the local community or environment;
- Waste minimisation and a commitment to restrict waste to landfill; ○ Management of waste disposal including re-use and recycling where appropriate;
- Communications, health surveillance and advisory facilities as required.
- Develop and review clear safety, health, quality and environmental performance indicators, which drive continuous improvement including ○ Accident and incident performance, including Near miss recording; ○ Annual safety, health, environmental and quality objectives; ○ Training achievement and requirements; ○ Customer satisfaction.
 - Internal and external audits.
- Review and, if necessary, revise this policy on an annual basis.

The Code Serve Ltd Director has the overall responsibility for this policy. Code Serve Ltd has appointed a Manager to be responsible and accountable for health, safety and environment whose responsibilities are set out in this Policy.
